Planning Application REF 17/04624/FUL Lammasfield Farm, Access Road To Lammas Field Farm, Erection of first storey extension and installation of photovoltaic array, solar panels and new windows and doors following demolition of existing extensions PENDING DECISION

Planning Application REF 17/06256/TPO Tree Works subject to TPO

Redhill House Red Hill: T1.Sycamore-Remove 4 limbs with diameter no greater than 5cm to crown lift. T2 to T5. Sycamore-Crown Lift with diameter no greater than 5cm. T6.Beech-Crown lift by removing 3 limbs. Cut back overhang in garden. Cuts no greater than 6-7cm. CONSENT

7.2 Planning Correspondence and other Planning Related Matters

Subject to checking the rules an enforcement matter to be passed to BANES Council.

7.3 Planning Application REF 17/02588/EFUL Parcel 4234 Combe Hay Lane Combe Hay Full planning permission for the erection of 171 residential units, open space, green infrastructure, landscaping and associated works including provision of vehicular access from Combe Hay Lane. The parish council unanimously agreed to respond by suggesting that the changes to the Park and Ride roundabout are not sufficient to mitigate the increased traffic so the application needs to take a completely new look at the infrastructure for traffic management e.g. introduce a new entry/exit into the Park and Ride. Cllr Fry left the meeting.

7.4Planning Application REF 17/06062/FUL 2 Sunnyvale Camerton Erection of 2no. rear dormers and 2no. front dormer windows. The parish council unanimously agreed to submit a response stating that they could not tell whether their design concerns had been addressed as there was no information submitted on the materials to be used for the construction of the dormer windows sides and roof.
