## 6HIGHWAYS, RIGHTS OF WAY & ALLIED MATTERS

- 6.1 Highway Related Matters Nothing to report
- **6.1.1 Update on Red Hill Build Outs** The majority of the implementation work is now finished. In light of comments received BANEs confirmed that due to the narrow width of the carriageway a cycle bypass cannot be implemented and a Walking, Cycling and Horse Riding Assessment & Review (WCHAR) was undertaken as part of the scheme design. Cllr McCabe has requested highways review the safety of pedestrians using a wheeled device. Note the A367 corridor study consultation will begin soon. This will be an opportunity to request further (funded by WECA) work on a Red Hill footway. A debate at the meeting including comments from parishioners focused on the following issues; loss of on street parking for unloading, reduced visibility of exiting from properties, cars encroaching onto the virtual footway, effect on pedestrian safety and not all road markings completed. These issues to be discussed by the chairman and highways.

- 6.1.2 Consideration of Approval of Repair of Fingerpost at Junction of Whitebrook Lane/Wick Lane based on quote received. As a quote not yet received this to be put on the agenda for the next meeting.
- **6.1.3** Consideration of How to Improve the Give Way by the old school on Camerton Hill. The Community Speedwatch group is getting more and more comments from people saying how aggressive drivers are on the approach to the GIVE WAY at the narrowing by the old school on Camerton Hill. Drivers are finding that cars approaching the GIVE WAY just plough on through especially if there are several of them rather than giving way. Clerk to raise with Cllr McCabe.
