# A guide to the Local Plan



## What is a Local Plan?

Prepared by Local Planning Authorities (LPAs), Local Plans are statutory documents which contain planning policies to guide and shape development.

Planning policies set out the design principles and requirements that development should follow.

They cover topics such housing, employment, climate change and other economic, social and environmental priorities. Policies can also be used to protect land from development.

Local Plans usually cover a period of 15 to 20 years and have a defined geographical area. Once adopted, the Local Plan is the main tool used to determine local planning applications.

## Why prepare a new plan?

We are coming to the end of our current Plan period. To ensure local planning policies are up to date, we need to produce a brand new Local Plan.

Work on the new Plan commenced in 2022, however, in December 2024 changes were made to national planning policy. This included changes to the way housing targets are calculated and how the Green Belt is defined.

To respond to these changes we have reset the Plan making process including engagement

# What does good look like?

## Our ambition

Access to high quality, affordable housing in the right locations is vitally important to addressing housing need. Focusing on housing alone, however, fails to deliver the types of places that people want to live in.

We want to create sustainable, vibrant communities that have a low carbon impact and are resilient in the face of climate change.

## The principles of good development

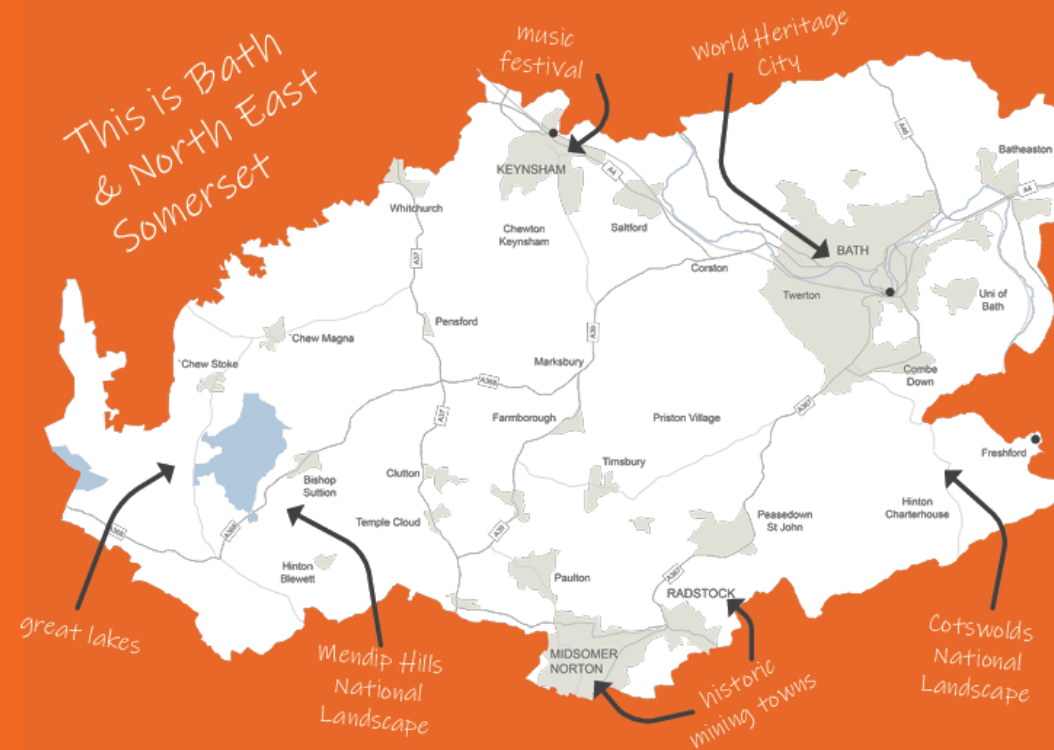
The principles of good development have long been established. There are 10 characteristics, as set out in the National Design Guidance (2021), that are essential for a well-designed place. These are...

- Enhances the local character
- Is attractive and distinctive
- Has a coherent pattern of development
- Is accessible and easy to move around
- Enhances and nurtures nature
- Has safe, inclusive public spaces
- Has mixed and integrated uses
- Has high quality homes and buildings
- Has efficient infrastructure
- Is adaptable and resilient
